Presidents and Vice-presidents of TSUS Faculty Senates met virtually met with Dr. Hayek, TSUS Vice Chancellor for Academic Affairs

TSUS CFS meeting: Friday, October 28, 9-11 AM 2022 via Zoom

Notable Items discussed:

- Dr. Hayek said data on faculty salaries should be available and he said he will strongly recommend to academic officers at components that that data be made available.
- LU-B reported that there has been discussion regarding giving more power/authority to the faculty senate—not just advisory role but rather want to act as a legislative body. LU reported Lamar University president has been supportive.
- Nelly Herra, Vice Chancellor/General Counsel, discussed role of Faculty Handbooks in policies. Also gave report on a college's right to revoke degrees.
- Texas should have plenty of money to spend.
- Other items discussed included low salaries and salary compression, tenure issues, the budget process, and shared governance.
