## COVID 19 Vaccine Incentive Program

**NO PURCHASE NECESSARY TO ENTER OR WIN.  
VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

### GUIDELINES

By participating in the Lamar State College Port Arthur (LSCPA) Vaccine Incentive Program (“**Incentive Program**”), you hereby acknowledge and agree to the following guidelines:

- 1) Participation in the Vaccine Incentive Program is completely voluntary. You are not required to receive a COVID-19 Vaccination (as defined below) in order to attend or be employed at LSCPA.
- 2) All entries must be received by 11:59 PM on Thursday, October 28, 2021 to qualify for the Vaccine Incentive Program.
- 3) **Weekly drawings will occur at 12:00 Noon each Friday beginning on October 1 and ending October 29.**

### ELIGIBILITY

An individual is eligible to enter the Vaccine Incentive Program if they meet all of the following requirements:

- 1) They are a student currently enrolled at LSCPA for at least one (1) semester credit hour course during the Fall 2021 Semester, OR they are employed (full-time or part-time) at LSCPA.
- 2) They are eighteen years of age or older, an emancipated minor, or have the signed permission of a parent or legal guardian; and
- 3) They have received at least one dose of a COVID-19 vaccine recognized by [the U.S. Food and Drug Association](#) or the [World Health Organization \(WHO\)](#) as having met the necessary criteria for safety and efficacy.

### HOW TO ENTER

Eligible Individuals may enter the Vaccine Incentive Program (“**Participants**”) by

completing the Vaccine Incentive Program Entry Form online at

Each Participant will receive only one (1) entry into the Vaccine Incentive Program.

### PRIZES

- 1) There will be separate and different prizes for students and employees.
- 2) Winners may not convert non-cash Prizes to cash or to any other thing of value.
- 3) Prizes are not transferable.

### WINNERS

- 1) Winners will be selected from among the Participants (each, a “**Winner**” and collectively, the “**Winners**”) in random drawings conducted by LSCPA.
- 2) **Winners will be notified via their LSCPA email address.**
- 3) Winners must acknowledge acceptance of the Prize in writing and will be asked to

provide proof of identification. The Dean of Student Services will review official vaccination documents to verify vaccination.

- 4) Failure to acknowledge acceptance of the Prize within seven (7) days of the Winner being contacted by LSCPA will result in the Winner's forfeiture of the Prize, and LSCPA will randomly draw another Winner to receive the Prize from among the remaining Participants.

**Taxes:** A Prize may be taxable, and Winner is responsible for payment of any taxes or fees associated with his/her Prize. Unless declined, the value of Winner's prize will be reported to both the IRS and Winner, on Forms W-2, 1099, or 1042-S, as appropriate.

#### PRIVACY

LSCPA will maintain the confidentiality of the Winner's Official Documentation in accordance with applicable privacy laws. Participants authorize LSCPA to verify their identity and their vaccination status. Documentation used to verify the proof of vaccination will be used for the sole purpose of awarding prizes. No documentation provided will be retained by LSCPA, nor will a record of vaccination status be kept.

#### PUBLICITY

Participants understand and agree that, if they win a Prize, LSCPA may disclose their name, image, and other directory information (such as classification and program of study) for the purposes of publicly announcing the Winners of the Prizes.

#### WAIVER OF LIABILITY

LSCPA shall not be liable to any Participant in the Vaccine Incentive Program for any damages, claims, expenses or other costs or fees (including, without limitation, attorneys' fees) that any Participant suffers or incurs as a result of their participation in the Vaccine Incentive Program or receipt of a Prize.

#### GENERAL

LSCPA has the right, in its sole discretion, to cancel or terminate the Vaccine Incentive Program at any time, for any reason, without any liability to Participants or any other persons. LSCPA also has the right, in its sole discretion, to disqualify any individual who violates any of these Guidelines; commits fraud or other misconduct in connection with the Vaccine Incentive Program; or interferes with, disrupts, tampers with, circumvents, or otherwise undermines the Entry process, or the operation of the Vaccine Incentive Program.

Participants understand and agree that any decisions with respect to the Vaccine Incentive Program made by LSCPA will be binding and final in all respects.

#### GOVERNING LAW & VENUE

The Vaccine Incentive Program (including the interpretation of these Guidelines) shall be governed by and enforced in accordance with the laws of the State of Texas. The venue for any dispute shall be Jefferson County, Texas.
