4. FIRST AID MEASURES

EYES:

SKIN:

Flush with water, then wash with soap and water. Remove saturated clothing. Get medical attention if irritation develops or open wounds are present.

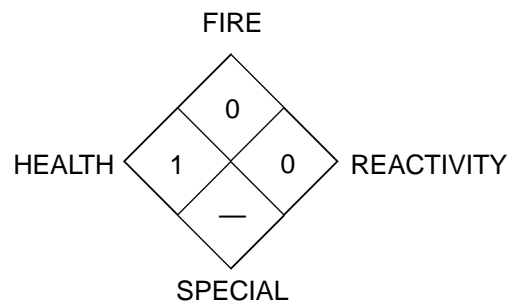
