#### EYES:

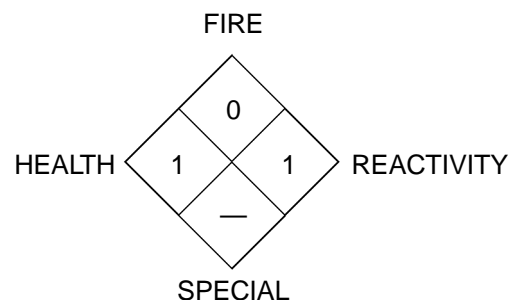
